FIRST AID

SKIN CONTACT - IF ON SKIN OR CLOTHING: Take off contaminated clothing and wash it before reuse. Wash with plenty of soap and water for several minutes. If skin irritation occurs: Get medical advice or attention.

GENERAL INFORMATION

A selected blend of modified vegetable oils and nonionic surfactants, **CLUB LINE MSD** will improve the efficacy of spray applications by aiding infiltration into the waxy cuticle of pests. By bringing the active pesticide ingredients past the surface and into the internal plant tissues, maximized control can be achieved.

DIRECTIONS FOR USE

Use CLUB LINE MSD with any pesticide that calls for MSO, ESO, MVO or other oil-based adjuvants, following the directions for their use found on the pesticide label. In the absence of experience with the combination of products being used, the applicator should perform a compatibility and phytotoxicity test before application. Special care should be used as this product may increase light sensitivity in some species. If the pesticide label does not provide a use rate for MSO, add 1-1/2 to 2 pints of CLUB LINE MSD per acre, adjusting as desired for environmental conditions, such as applying in dry dusty conditions or for mature weeds with thick waxy cuticles.

MIXING INSTRUCTIONS

Always follow mixing order instructions found on the pesticide label.

If instructions are not provided, follow these recommendations:

- 1) Fill spray tank 2/3 or 3/4 full of water.
- 2) Add dry flowables (DF) and wettable powders (WP).
- 3) Agitate until thoroughly dispersed.

4) Add additional active ingredients, adjuvants and CLUB LINE MSD. Note: For best results, apply tank mixes that include CLUB LINE MSD within 36 hours of mixing.

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
