# **FIRST AID**

# GENERAL INFORMATION

CLUB LINE ORGANOSILICONE is an organosilicone nonionic surfactant mixture designed for water-based herbicide application. CLUB
LINE ORGANOSILICONE wets and spreads more efficiently than standard 90/10 or 80/20 nonionic surfactants without the runoff or
damage that sometimes occurs with 100% organosilicone surfactants. CLUB LINE ORGANOSILICONE is designed for fast spreading;
uniform distribution and absorption of spray on leaf and stem surfaces. CLUB LINE ORGANOSILICONE may be used with most
pesticides and fertilizer products. Optimum application and consequent effects can be influenced by many factors. It is
recommended that the spray be observed and adjuvant rates be adjusted accordingly. During application insure thorough
coverage without excessive runoff.

### DIRECTIONS FOR USE

Always follow the directions on the label of the pest control agent being used. **CLUB LINE DRGANDSILICONE** is designed for use where an organosilicone surfactant is recommended or not forbidden. Suggested rates for the use with various categories of pest control agents are as follows:

Aerial Application: When applying aerially, follow pesticide label directions including minimum water volume per acre. Do not substitute CLUB LINE ORGANOSILICONE for water required by the pesticide label.

For increased water penetration of hard to wet soils and the uniform distribution of applied moisture follow recommended uses:

# MIXING INSTRUCTIONS

Spray mixing and application equipment must be cleaned according to cleaning directions on prior pesticide label before application

To minimize foaming, fill spray tank 2/3 or 3/4 full of water. If foaming is anticipated, an antifoaming agent should be added before CLUB LINE ORBANICSILICONE. While under agitation, pesticides and/or fertilizers should be added as directed by label or in the following sequence: Powders (soluble), Powders (dry), Liquid flowables and suspensions, Emulsifiable concentrates and solutions

While agitating, add CLUB LINE ORGANOSILICONE and mix for 1 to 2 minutes with lower than normal agitation. Continue filling tank maintaining minimal agitation.

## STORAGE AND DISPOSAL

Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F. Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
