## **DIRECTIONS FOR USE**

MultiPath is safe throughout the entire growing season and will not discolor or harm plants when applied according to label directions. For best results, apply before plants show signs of stress or circumstances that decrease moisture penetration. MultiPath will not interact with most tank additives or active formulas. To increase performance in hard water or where water quality is not ideal, use of MultiPath more often at lower rates is recommended. Other factors such as environmental temperatures/humidity and soil type/quality may also affect the application frequency and the amount of product necessary to properly treat the soil and achieve optimum results.

## **APPLICATION RATES / INTERVALS**

SPRAYERS and HANDHELD SPRAYERS: Apply 0.5 to 3.0 ounces per 1,000 square feet every 3 to 4 weeks. All applications of MultiPath should be applied in a minimum of 1.5 gallons of water per 1,000 square feet. Apply only as directed.

INJECTION FOR IRRIGATION SYSTEMS: For best results, MultiPath should be distributed evenly over a 1 month period. Start with 32 ounces per acre. Inject into irrigation system with enough water so that complete and even coverage is obtained. If inadequate penetration is achieved, increase the use rate by 8 ounces per acre. Repeat increasing the usage rate until proper permeation is achieved. If permeation appears to be too fast, decrease the usage rate to achieve desired results. Repeat monthly, as necessary.
