APPLICATION RECOMMENDATIONS

COMPONENT PK is effective as a direct foliar application or fertigation type product. May be tank mixed or injected with other fertilizers or agricultural chemicals after conducting a jar test for compatibility. TURF SPRAY APPLICATION: Apply 3 to 9 ounces of COMPONENT PK per 1,000 sq. ft. every 7 to 14 days in at least 1 gallon of water. Apply only as directed.

6 ounces per 1,000 sq. ft. provides 0.09 lbs of K
