For optimum results, apply Cycle™ at the first signs of drought stress or before signs appear. While watering after application is not required, irrigation will improve performance by moving the product into the soil profile. If grass cutting is performed prior to irrigation, do not remove clippings as much of the product may still be on the leaves. During high temperatures and severe turf stress the following precautionary measures are highly recommended: pre-wet the leaf blades before application and water in immediately after application to ensure product performance and safety.

## APPLICATION RATES / INTERVALS

**MONTHLY APPLICATIONS:** Apply Cycle™ at a rate of 4 ounces in a minimum of 1 gallon of water per 1,000 square feet.

**2-WEEK APPLICATIONS:** First apply Cycle™ at a rate of 4 ounces in a minimum of 1.5 gallons of water per 1,000 square feet. Then apply Cycle at a rate of 2 ounces in a minimum of 1 gallon of water per 1,000 square feet every 2 weeks thereafter.

Repeat applications until drought stress conditions cease in order to prevent symptoms from returning.

## MIXING INSTRUCTIONS

If Cycle™ is mixed with other chemicals such as pesticides, always follow label instructions on the product with which Cycle™ is being mixed. A jar test should be performed in order to ensure compatibility. Apply some of the jar test mixture to a small turf area and observe the turf area for safety.

**ORDER OF ADDITION:** (Mix vigorously during all additions)

- 1) Part or all of water.
- 2) Wettable powders and then dry flowables.
- 3) Adjuvants such as defoamer and buffer compounds.
- 4) Liquids and Soluble products.
- 5) Emulsifiable Concentrates.
- 6) Cycle™ and other surfactants.
- 7) Top off with water to desired tank volume.
