APPLICATION RECOMMENDATIONS

FAIRWAY N is effective as a direct foliar application or fertigation type product. May be tank mixed or injected with other fertilizers or agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications.

TURF SPRAY APPLICATION: Apply 3 to 12 ounces of FAIRWAY N per 1,000 sq. ft. every 14 to 28 days in at least 1 gallon of water, as needed to maintain healthy turf. Apply only as directed.
