### GENERAL INFORMATION

Perk offers professional turf managers a reliable water management tool that provides up to 4 weeks of water penetration into the soil profile. It improves water infiltration so water can move evenly into soil profiles and provide adequate soil moisture for root uptake.

### DIRECTIONS FOR USE

Perk is safe to use throughout the entire growing season and will not discolor or harm turf when applied according to label directions. For best results, Perk should be applied before the grass shows signs of stress or circumstances that decrease moisture penetration. To increase performance, use of Perk more often at lower rates is recommended. Different conditions such as water hardness, environmental temperatures and humidity, soil type and quality, and other factors will affect the application frequency and the amount of product necessary to properly treat the soil and achieve optimum results.

### APPLICATION RATES / INTERVALS

Monthly applications: Inject Perk at 32 oz per acre into an enclosed irrigation system. Use incremental rates of 8 oz per acre during extreme drought until desired results are achieved. Do not exceed a 1 gallon per acre rate or 128 oz per acre rate.

Bi-weekly applications: First, inject Perk at a rate of 32 oz per acre into an enclosed irrigation system. Then apply at a rate of 16 oz per acre every 2 weeks thereafter. Use incremental rates of 8 oz per acre during extreme drought until desired results are achieved. Do not exceed a 1 gallon per acre rate or 128 oz per acre rate.

Repeat applications until drought stress conditions cease in order to prevent symptoms from returning.

### MIXING INSTRUCTIONS

If Perk is mixed with other chemicals such as pesticides, always follow label instructions on the product with which Perk is being mixed. A jar test should be performed in order to ensure compatibility.

### STORAGE INFORMATION:

Store in a cool, dry place in original container. Do not add water to container. Store away from extreme heat, fire, flame or sources of ignition. This product is best stored and handled between 40°F (4°C) and 90°F (32°C). If product freezes, warm until free-flowing and shake.
