



APPLICATION RECOMMENDATIONS

RUCKUS® is effective as a direct foliar application or fertigation type product. May be tank mixed or injected with other fertilizers or agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications.

TURF SPRAY APPLICATION: Apply 32 to 128 ounces of RUCKUS® per acre every 7 to 28 days in 1 to 2 gallons of water, as needed to maintain healthy turf. Maximum rate is 2 gallons of Ruckus® in 1 to 2 gallon of water per acre when recommended by a Sales Representative or Agronomist. Apply only as directed.

Do not apply if a heavy rain is expected. Do not apply near water, storm drains, or drainage ditches. Apply only to intended application area.
